The guarantee objects are as follows:

- coverage of costs of clients return journey to the departure place or costs of planned return after a travel event in case when the Applicant, against his obligations, does not provide this return,
- coverage of reimbursement of payment for a travel event in case when the event does not take place due to the reasons concerning the Applicant or persons acting on his/her behalf,
- coverage of reimbursement of part payment for a travel event in the part corresponding to that part which would not take place due to the reasons concerning the Applicant or persons acting on his/her behalf acc. to the Act dated 29th August 1997.

The guarantee sum amounts
PLN 220 785,00

which is equivalent of EUR 50 000 (in words: fifty thousand EURO) calculated on the base of average rate of exchange published by the Polish National Bank for the first time in the year when the guarantee has been issued, it means on 2nd January 2017 (1 EUR= 4,4157 PLN).

Obligations of the Warrantor concern the activity of Applicant being conducted:

- a. within Republic of Poland (also the events for the incoming tourists) as well as in the countries having land border with Republic of Poland, and in case of the Russian Federation in area of the Kaliningrad Oblast, acc. § 2 item 4 of the directive dated 19th April 2013 establishing the minimal bank guarantee sum or insured sum required in respect to the activity performed by tour operators and travel intermediaries ((L.G. 2013 r., pos. 511);
- b. within the European countries, while using other transport than the aircraft once in frame of the charter flights (with exclusion of Republic of Poland and the countries having land border with Republic of Poland and in case of the Russian Federation – the area of the Kaliningrad Oblast), acc. § 2 item 3 of the directive dated 19th April 2013 establishing the minimal bank guarantee sum or insured sum required in respect to the activity performed by tour operators and travel intermediaries ((L.G. 2013 r., pos. 511);
- c. within the non European countries independently from the means of transport and within the European countries, while using aircraft transport in frame of the charter flights (with exclusion of Republic of Poland and the countries having land border with Republic of Poland and in case of the Russian Federation – the area of the Kaliningrad Oblast), acc. § 2 item 2 of the directive dated 19th April 2013 establishing the minimal bank guarantee sum or insured sum required in respect to the activity performed by tour operators and travel intermediaries ((L.G. 2013 r., pos. 511);
